 - 4.1 1 member of the public attended.

- 8. GROUNDSKEEPING AND MAINTENANCE REPORT:
- 8.1 Staff reported that: 1) Trees were trimmed along border between old/new sections of cemetery 2)the fall color change has been completed 3) there were bees in the ground that

had to be exterminated 4) the brick columns at the gate were hit again. Have the taillight piece from vehicle 5) there was a broken water line. Used the backhoe to dig it up and repair it 6) large limb broke off an oak tree at entrance to new section and broke a hose bib. 7) the new BSM system and server should be in the office in a few weeks 8) hired a professional rodent control person to capture the raccoon digging up the new sod

 - 9.1 Staff reported annual returns on the District's four investment accounts: Capitol Improve: 3.33%, Endowment Principal: 3.48%, endowment interest: 3,35%, Pre-need: 3.55%
 - 9.2 Status of reconveyance of utility easement: Tony Condotti reported that PGE finally

replied to continued contact by his office. Hopefully there will be some action.

9.3 Status of SND development: rose bushes are installed, a tree has been replaced that died, Manager Reed will be learning about the fountain and the timer this week, still need the curbs marked.

- 9.4 Discussion of brochure: Trustees Bosworth and Nunn presented more ideas for the brochure. Suggestions were made. Work will continue on selecting photos and layout.
- 9.5 Discussion of fountain tile: Manager Reed will ask if the granite wheel can be lowered. If the wheel can be lowered, there was consensus that the tile will be fine. There was also discussion about working with the water pressure to see what difference less pressure would make to the sound/look of the fountain; as well as more pressure. Currently no decision on replacing/covering the blue tile.

10.1 Discussion of LAFCO membership: continued discussion about value of encouraging

the Special Districts Assn. to hold 2 seats on the LAFCO board, especially due to a civil grand jury report of 2011 which specifically listed the Saratoga Cemetery District as obsolete. No action taken.
