 - 6.1 Written: Staff presented:
 - a) One buy notice for a bond held in the District's investment portfolio.
 - b) An email offering aerial photography of the cemetery on an approval basis. The Board expressed interest in the no risk offer. Staff will arrange for an aerial photo shoot.
 - 6.2 Oral: Judy Johnstone informed the Board that she will be unavailable to attend the Santa Clara County Special Districts Association meeting on Monday, June 2. There are no items that affect the cemetery district but the Saratoga Fire District would like support from other special districts to prevent dissolution of their District after merging with Central Fire District. The cemetery district will not be represented at the meeting.

- 10.2 Staff updated the Board on the current status of the well. The recommendation for getting the well operational is to repair the current pump and install two 5,000 gallon storage tanks and auxiliary pump. The Board was receptive to the idea, staff will solicit bids for the work.
