4) First reading of B.P. 511: The Board conducted the first reading of B.P. 511. The Board discussed many changes to the policy as read. Steve Albright will rewrite the policy and submit it at the June Board meeting for first reading.

5) Review water plan: Steve Albright discussed the current water access plan which is at maximum capacity and discussed ways to further access more water when the cemetery expands turf areas.

6) Manager's report:

a) Steve Albright reported on the progress of the road paving project. Southbay Paving has removed and replaced most of the broken asphalt and is now working on the ADA parking area. They are having difficulties obtaining the proper grade require by ADA and this may change the arrangement of the parking stalls. They estimate the project will be completed in two to three weeks.

b) Memorial Day services are scheduled for Monday May 28th. The cemetery staff has been working diligently to prepare the cemetery for the event.

c) The Madronia Arboretum sign has been installed in the Pavilion.
