REGULAR AGENDA ITEMS

- 1) Tour Madronia's undeveloped and discuss future development: The Board toured the undeveloped 1.6 acres located along the south border of the cemetery. Norman Koepernik shared his development thoughts with the Board. The Board would like Steve Albright to contact Lees & Associates to help with interment design.
- 2) Review progress of Cremation Garden: Steve Albright reported the hardscape portion of the cremation garden should be completed before the next Board meeting and we should decide on the softscape portion of the project as soon as possible.

The project will require some road modification in front of the cremation garden. Steve Albright will contact Southbay Paving to review the project.

3) Discuss development of Blocks 85-88: Steve Albright reported all construction is complete except for the roses.

Dan Cable of Latitude 24 will be out on October 28th to check measurements before the mapping can begin.

- 4) Discuss District's Non Resident Fee: Board discussed the Non Resident fee. No action taken. Forward to November Board meeting.
- 5) Review Resolution 2021-4: Resolution 2021-4 was presented to the Board to transfer County Maintenance & Operation funds to Stifel Endowment Care Interest. Vicky Bosworth moved to accept Resolution 2021-4 as presented. Motion second by Sheila Couch. Unanimous.
- 6) Create an urn capacity policy for the new columbarium: The Board discussed the urn capacity. Steve Albright reported the niche will hold six standard urns, but it would be difficult to place six individual inscriptions on the granite shutter.

Norman Koepernik moved to set the urn capacity to 4 urns. Motion second by Sue Fitzpatrick. Unanimous.

7) Discuss Land Acquisition: The Board would like to invite local realtor Tiger Tierlink to the January Board meeting to discuss representing the District in acquiring land for the District.

The Board will discuss the details of the meeting with Mr. Tierlink at the November Board meeting.

- a) Steve Albright reported on the California Association of Public Cemeteries conference on October 8th & 9th. The first day of the conference was about Trustee role in the District. The second day included a question and answer session and harassment training as required by California law.
