- <u>Discuss Land Acquisition:</u> No action taken. Norman Koepernik will work with the city of Saratoga to obtain soil testing reports and geological reports for tract 6628.
- 2) <u>Discuss Tranquility Garden signage, benches and statues:</u> Norman Koepernik reported the Tranquility sign is installed and he is still looking for benches.
 Steve Albright presented a proposal from Pacific Water Art for \$23,675.00 to install the fountain for Tranquility Garden. Norman Koepernik will review the proposal before any action is taken.
- 3) Review design plan for Block 76: Vicky Bosworth presented the concept of a large boulder as focal feature in the columbarium area of block 76. Norman will draw a new conceptual plan for the next meeting.

- 5) Manager's Report: Steve Albright reported the following.
 - Bank of the West was purchased by BMO and all accounts transferred properly.
 - b. A vehicle recently struck and damaged the brick pillar at the entrance. I have contracted a crew to make the repair. The repair will be completed tomorrow.
 - c. I received a phone call from our neighbor Dennis Hunter about our fence. The fence between our properties is leaning and Dennis would like it repaired without disturbing any shrubbery on the fence. I contacted PL Fence Company to repair the fence. The repair requires the shrubbery be removed for the repair to be made. I will contact Dennis to try to satisfy his request.
 - d. I received an invoice from Flora Terra Landscaping for services not billed since December 2019. Most of the unbilled invoices are less than 90 days old and are now currently paid. The remaining invoices total \$21,510.60. I will research each invoice to verify our financial responsibility before paying the invoice. The Board may need to pass a resolution to increase the budget to accommodate the payment of the past invoices.
