- 2) <u>Discuss Tranquility Garden signage, benches and statues:</u> Norman Koepernik reported the signage letters have been ordered but not received. Norman will be looking at more benches before the next board meeting. Norman has also been looking at spouts for the fountain in Tranquility Garden.

The Board would like Steve Albright to obtain a bid to install a small fountain in the garden.

3) Review design plan for Block 76: The Board reviewed and discussed the design plans prepared by Lees+Associates. The Board discussed several minor changes to the plans. No action taken. Norman will stake out the cremation garden measurements for the Board to review at the next Board meeting.

Steve Albright reported the additional design work from Lees+Associates will cost \$3200.00.

- 4) <u>Discuss new cemetery software:</u> The District office has a meeting scheduled with Vicky Bosworth on Tuesday July 25 at 10:00 am to review Quickbooks as a software option.
