#### REGULAR AGENDA ITEMS

- 1) Discuss Block 75 & 76 development with Dan Cable from EDA Lan Planning: Dan Cable recommended we add 80 to 90 full monument graves to the end of Block 75. Dan also recommended we rotate the graves in Block 76 to east. This will allow the addition of 42 graves and will be easier to access for grave openings and maintenance. Dan suggested we remove the cremation monuments graves and columbariums from the block 76 design and add cremation gardens within the various unused areas of the cemetery.
- 2) Review and discuss progress of the Lomita property repairs and improvement: Steve Albright reported all repairs have been competed except for the removal of the swimming pool.
- 3) <u>Sign BMO signature cards:</u> Steve Albright suggested we postpone signatures until all Board members are available to sign.
- 4) <u>Discuss Congress Springs property survey:</u> Norman Koepernik reported the scheduling of the survey is still in the works.
- 5) <u>Discuss article for California Special Districts Association:</u> Steve Albright reported he had spoken to Colleen Healy from CSDA about the article about achieving a level 2 arboretum status. Steve felt it was a premature for an article. Colleen will contact us next year.
